Applications are invited from intending eligible candidates who are citizens of India as defined in Article 5 and 6 of the Constitution of India, in the prescribed Standard Form under Assam Gazette of part-IX for filling up of vacant post (highlighted here under in the table) in the establishment of Labour Court, Guwahati with pay structure plus other allowances as admissible under the rules.

**TERMS AND CONDITIONS FOR APPLICATION :**

1. The candidate must be an Indian Citizen as defined in Article 5 to 8 of the Constitution of India.
2. The age of the candidate must not be less than 21 years of age and more than 40 years of age as on 01.01.2025. The upper age limit relaxation is 5 years for SC/ST candidates; 3 years for OBC/MOBC candidates.
3. Preference will be given to the candidates having working experience in any district Court/ Tribunal of Assam.

4. The candidate who has no relevant qualification & experience need not apply.

**Mode of Selection :**

1. Eligible candidates will have to appear in
  - (i) Written Test
  - (ii) Skill Test in computer Typist
  - (iii) Viva-voce.

Candidate securing highest mark in total will be selected.

**HOW TO APPLY :**

1. The eligible candidates must submit their applications in the Standard Form published in Assam Gazette Part-IX only in offline mode.
2. The application must be accompanied with the following document.
  - a) 2(two) copies of recent passport size coloured photographs with signature.
  - b) Self- attested copies of all testimonials in support of his/ her AGE,CASTE & relevant EDUCATIONAL QUALIFICATION, EXPERIENCE etc.
  - c) Valid Employment Exchange Registration Certificate.
  - d) Certificate of Degree or Diploma in Computer Application.
  - e) At least one year Experience Certificate in the relevant field.
3. Applicants will have to produce all the testimonials in original, in the event of being selected for interview failing which his/ her candidature will be rejected.

Also the applicants are to super scribe the post applied for on the top of the envelope without fail. The applicants are to submit their applications in the drop box on placed at the Office of Labour Court, Guwahati.
